Collection of Personal Information

THINK may collect and process personal information (as defined in the Protection of Personal Information Act, 2013) (POPIA) from you when you interact with our organization, such as when you visit our website, make a purchase, or contact our customer service team. The types of personal information we may collect include your name, contact details, and financial information. We will only collect personal information that is necessary for us to provide our services to you and to meet our legal and regulatory requirements.

Use of Personal Information
